

Clinton County Farmers Market “Kids Market”

Special Event

Our Goal:

*The goal of the *Kids Market* is to allow a space where kids have an opportunity to sell their crafts or items they have made or produced. Items must be primarily produced by the kids with limited parent/guardian assistance as needed.

*The Kids Market will allow kids to experience what it is like to invest in an idea, and use their creativity to produce items that others will want to purchase.

In 2024, we have scheduled two “*Kids Market*” dates to be held on July 20th and September 21st. Kid vendors may participate in one or both markets.

Rules for Kid Vendors and Parents/Guardians:

1. The Clinton County Farmers Market opens at 8:30 am and closes at 12 noon. Set up may begin at least by 7:30 am and must be set up by 8:15 am. Attendance is required for the entire market time. *Markets are held rain or shine.*
2. Kid vendors must be between the ages of 7 to 17 years old.
3. The Market is held at the Clinton County Courthouse Square parking lot at the corner of Walnut and Sugartree streets in downtown Wilmington.
4. Kids Vendors will be assigned a space by Market staff.
 - a. Each vendor must provide their own display.
 - b. Vendors will supply their own canopy, chairs and table.
 - c. Canopy size allowed is 10 ft. x 10 ft.
 - d. You must ensure your canopy is secure by anchoring all four corners regardless of the weather. Recommend heavy weights such as gallon jugs filled with rocks or sand.
 - e. You must clean up their space at the end of the Market. All trash must be removed. It is a good idea to bring a small trash can for your booth.
 - f. Set up can be a simple table but we encourage you to decorate your table to attract the attention of potential customers.
5. All product prices must be easily visible to the customers either by labeling each item or using a sign.
6. It is recommended you focus on a single or not more than a few varieties of items for sale. Quality is important more than quantity.

7. Kid vendors must have a responsible adult attend the entire market.
 - a. The responsible adult will ensure their child maintains a respectful attitude toward the customers. There will be no yelling or disruptive sales tactics or behaviors.
 - b. There will be no gossip, arguments, harassment, name calling, profane language, or fighting with other vendors.
 - c. There will be no use of social media that in any way depicts the other vendors or market in a negative light.
 - d. Kid vendors or responsible adults will not be permitted to use tobacco products of any kind within the Market boundaries. Any tobacco use must take place outside of the entire Market space.
 - e. Violations are grounds for dismissal and revocation of future Market privileges. This policy will be enforced by the Clinton County Farmers Market management.
8. The Kid vendor and their responsible adult are solely responsible for the security of their items and cash box. Please bring adequate cash to make change. The Market is unable to make change for you.
9. Any product sold is the responsibility of the responsible adult to ensure they are in compliance with all state and local laws, codes, and standards.
10. All home baked goods must be labeled to meet the Ohio Department of Health Food Safety Standard. Go to <https://agri.ohio.gov/wps/portal/gov/oda/divisions/food-safety/resources/cottage-food> for information on labeling requirements and eligible baked goods for selling at a farmers market.
